A24-010 Consider Iowa Department of Transportation (IDOT) Revitalize Iowa's Sound Economy (RISE) Grant Application (Director of Engineering)

Des Moines Airport Authority is submitting a joint application with the City of Des Moines for a Revitalize Iowa's Sound Economy (RISE) grant from the Iowa Department of Transportation (IDOT) to help fund the Cowles Drive Phase 4 construction. Phase 1, 2 & 3 of Cowles Drive construction is complete and was awarded a RISE grant from IDOT in calendar year 2020 and 2021. The realignment of this roadway changed the entry to the Airport Terminal Area but will not change its functionality. RISE grant awards typically fund 50% of eligible project scope of work. The construction project estimate for Cowles Drive Phase 4 is approximately \$10,319,627, RISE eligible costs are approximately \$7,026,700. This would allow for an estimated RISE grant of \$3,513,350 (includes construction, engineering, and contingency). As part of this grant application, the IDOT requires an Airport Authority Board resolution and endorsement of the project.

Staff Recommendation: Approve the IDOT RISE Grant Application for Cowles Drive Phase 4, authorize the Executive Director to accept and sign the grant award once received from the IDOT, and authorize the Director of Engineering and Planning to accept and close out this grant when completed in accordance with the contract documents.
